Note 1: State and Federal agencies have a long-standing commitment and PCAs to completing these projects which are considered foundation projects upon which CERP will continue to build restoration benefits.						
Note 2: Herbert Hoover Dike is not listed here because it is funded through a separate funding source from the South Florida Everglades Ecosystem Restoration effort. However, it is an essential feature for the health and public safety of South Florida ecosystem, as well as to the ability to maintain the health of the lake and estuaries, and will require a substantial financial commitment from the Corps over the next several years.						
Note 3: State has additional restoration efforts, including the Northern Everglades initiative and the Everglades Long-Term Plan, that will complement CERP and the Foundation projects. The programs and initiatives will also require significant funding and staff commitments.						
Note 4: Most of these projects were either initially authorized in WRDA-2000 and/or fully authorized in WRDA-2007. In October 2003, the Federal and State agencies jointly agreed to accelerate implementation of these projects. Since then, significant State and Federal resources have been committed to land acquisition, planning/NEPA, detailed design and construction of these projects.						
Note 5: For the North Palm Beach - Part 1 Project, the SFWMD has committed to working with Palm Beach County and the Corps to incrementally accelerate construction of select features to gain early restoration benefits. For the C23/C24 STAs, the Corps has expedited design and is nearing completion of final plans and specifications in a commitment to Martin County to initiate construction as soon as funding for construction is authorized.
